Founders Days, Inc. RESERVES THE RIGHT TO DISQUALIFY ANY VENDOR CAUSING ANY PROBLEMS TO FELLOW VENDORS, COMMITTEE MEMBERS OR THE GENERAL PUBLIC OR THAT POSES A SAFETY HAZARD IN ANY WAY.

Failure to comply with the attached rules and regulations set forth may result in expulsion from the event. ## **TERMS AND CONDITIONS**

THE REGISTRATION FEE WILL BE DEPOSITED UPON APPROVAL AND WILL NOT BE REFUNDED.

One exhibitor is allowed per space. No subletting or sharing of space is permitted. Once registration is confirmed, transfer of a vendor space to an unregistered vendor is prohibited.

Exhibitor must comply with all local and state and federal laws and regulatory rules and regulations of the show.

An application is a commitment to show and no refund will be made.

Any space will be forfeited for failure to appear by 2 pm on Friday of the festival.

All applications must be completed and returned by January 15th, 2009 and must be accompanied by the appropriate fees to be accepted. No checks or cash payments will be taken at event set-up. Payment must be received in full prior to set-up.

## **ELECTRIC**

Electric fee is included with vendor fee only if requested before the event with original registration. You must supply your own electric cord for plug in. Lighting/electricity for the inside of your tent must meet the following specifications: no metal clamps, no flat cords, only 12- gauge round cords and only UL approved outdoor grounded cords may be used. All power cords must be taped down.

## **TENTS**

Exhibitor owned tents must conform to booth size. Construction of booth and displays must be able to withstand inclement weather and crowd activity. Tents must be manufactured of flame-retardant materials. The approved exhibitor will occupy his or her booth at all times. Contents of booth will not go beyond the assigned exhibitor space. Your booth should not interfere with your neighbor's booth. Committee shall make the final determination.

**PLEASE NOTE:** If you have selected the option of having a tent provided for you, this includes the tent only. This does not include tables, chairs or sides on the tent. However, if you need sides on your tent, this can be arranged in advance. There will be a charge of \$10 per tent side.

## **RESTRICTIONS**

It is restricted by the City of Deerfield Beach that items are sold from the front, crowd side, of the vendor space only. Otherwise, displaying and selling items from the back of the tent, the sidewalk side, is prohibited. This forces crowds to

have to maneuver around electrical hook-ups, cords etc. and represents a safety hazard. Vendors may only sell items within their tents. Otherwise, it is prohibited to walk through the crowd or near the stages to sell items. Set-up and breakdown times will be strictly enforced. You must arrive at the specified time. Tardy exhibitors may be excluded from setting up. Breakdown will not begin until the end of the event. Vehicles will not be permitted into the show area until all visitors have left the area. The COMMITTEE will have the final decision on this safety precaution.

**EXCLUSIVITY**

No exclusivity will be permitted for vendors, however care will be taken during vendor registration to prevent duplicity of similar items. Sale of items is limited to those named on the application and approved by the Committee.

**PLEASE NOTE:**

Exclusivity has been granted to the 2009 Food Vendor. Therefore, it is prohibited that Craft Vendors sell any food items or beverages; this includes bottled water, sodas, juices etc. No refunds will be given to any vendor leaving the event due to any circumstance i.e. inclement weather. No fuels or open equipment allowed in display area. Exhibitors are responsible for securing items after closing times. Overnight security is provided for Friday and Saturday night only. However, all merchandise is left overnight at the vendors risk. A special parking area for exhibitors will be provided with limited parking passes.

**NO VEHICLES CAN ENTER OR REMAIN IN THE DISPLAY AREA DURING THE EVENT.** Violators will be evicted from the event without refund. Any Vendor that brings a vehicle into the display area before 9 pm on Sunday night, attempting to leave the festival early, will be deemed causing a public safety hazard and will be ticketed by the Broward Sheriff's Office.

This contract shall be deemed to have been made in the State of Florida and shall be interpreted in accordance with the laws of the State of Florida. All legal action to enforce this agreement shall be brought into the courts of Broward County, Florida, and the exhibitor agrees to the jurisdiction of the courts. Founders' Days of Deerfield Beach, Inc. and the City of Deerfield Beach will not assume liability for any act of God, natural disaster, exposure to adverse weather conditions, damages, injuries or any legal authority, or any cause above and beyond the control of Founders' Days of Deerfield Beach, Inc.
